The 2005 Administrative Law Conference will be held at the Marriott at Metro Center, 12th and G Streets, NW, Washington, DC. Conference Housing

The Marriott at Metro Center is the host hotel for the 2005 conference. The negotiated room rate for conference attendees is \$189.00 plus tax for a single or double.
