- (3) the nonexclusive worldwide right to use the Work, or any part thereof, in any other publication produced by the MSBA. In addition, you assign the nonexclusive worldwide right to use the Work to promote and publicize the MSBA or its publications, including the right to use your name and likeness and biographical data in such promotions. If published, you will be identified as the author of the Work, or coauthor if applicable.

You warrant that the Work is original with you, that it is not subject to any existing copyright and that you have authority to grant the rights in this Agreement; that its publication will not libel anyone or infringe on or invade the rights of others and will not cause harm to anyone; that you have full power to make this Agreement; and that the Work has not been published elsewhere in whole or in part (except as may be set out in a rider attached herewith), and that you will indemnify and hold harmless the Minnesota State Bar Association for claims arising from publication of the Work as part of *Bench & Bar of Minnesota*. Should the Work contain any material that requires written permission for inclusion in the Work, you agree to obtain such permission from the copyright proprietor consistent with this Agreement.

If the foregoing terms are satisfactory, please sign and date this Agreement below and return it to the Director of Publications. Execution of this Agreement does not obligate the MSBA to publish your Work.
