AUTHOR'S AGREEMENT

I am submitting the accompanying article for consideration for publication in *The Hennepin Lawyer*.
The tentative title of the article is,

In consideration for evaluating my article for publication, I hereby grant to the **Hennepin County Bar Association** the following rights:

- (a) The right to first publish the article.
- (b) The exclusive right to publish the article for a period of 210 days from the submission of the article or the date this signed agreement is received by the HCBA, whichever is later.
- (c) The right to publish the article in publications of the Hennepin County Bar Association and on the association's Web site.
- (d) The right to reprint and sell copies of the article as reprints of back copies of *The Hennepin Lawyer*, including on/via the Internet.
- (e) The right to permit reproduction of the article or portions thereof in non-profit legal publications and in bar association promotional materials.
- (e) The right to grant permission to abstract the article for indices to periodicals.
- (f) The right to permit reproduction of the article or abstracts thereof in computer-assisted legal research services (*e.g.*, Westlaw).
- (g) The right to use my name and biographical data in connection with the article and promotion of HCBA publications.

The granting of the above rights expires in ninety (90) days from the submission date absent an agreement to publish by *The Hennepin Lawyer*. If the HCBA wishes to publish the article, it will send the author an agreement to publish within that 90-day period. (The agreement to publish will provide that if the article has not been published in the magazine within 120 days of the agreement to publish, all rights revert to the author. The author and the association may extend this limit by mutual agreement.) The agreement to publish must be mailed to the author(s) at the address provided below. All rights revert to the author(s) on notice from *The Hennepin Lawyer* that the magazine has chosen not to publish the article.

I understand that the editor(s) may edit my submission, making changes to the original submission.
