## **DIRECTWOMEN ANNOUNCES 2008 SANDRA DAY O'CONNOR BOARD EXCELLENCE AWARD HONOREES**

CHICAGO, Dec. 3, 2007—DirectWomen announced today the six recipients of the 2008 Sandra Day O'Connor Board Excellence Award honoring women lawyers who have served with distinction as independent directors of public companies and have worked to advance the value of diversity in board positions.
