

**STATUS OF STATE REVIEW OF PROFESSIONAL CONDUCT RULES**  
(as of September 29, 2009)

Forty-two (42) states and the District of Columbia have adopted revised rules (AL, AK, AZ, AR, CO, CT, DE, DC, FL, IL, ID, IN, IA, KS, KY, LA, ME, MD, MN, MS, MO, MT, NE, NV, NH, NJ, NM, NY, NC, ND, OH, OK, OR, PA, RI, SC, SD, UT, VT, VA, WA, WI, WY).

Five (5) states have circulated proposed rules (CA, MI, TN, TX, WV).

Three (3) states have committees that have not yet issued a report (GA, HI, MA).
