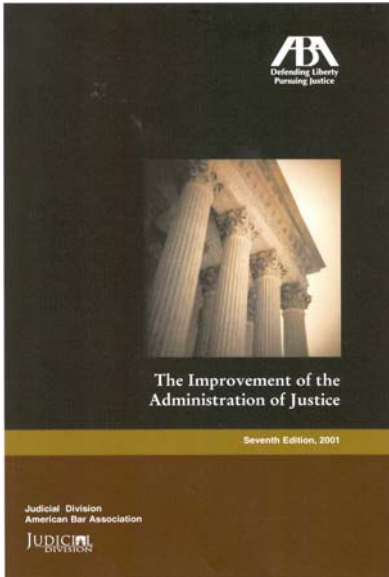


# THE IMPROVEMENT OF THE ADMINISTRATION OF JUSTICE
