### ABA Associate Affiliation

Article Three of the ABA Constitution and Bylaws provides for the establishment of classes of Associates, composed of nonmembers with whom affiliation is considered to be in the interest of the Association. Associates are not members of the American Bar Association and do not, as a group, constitute a membership classification. Associates of the American Bar Association, except for International Law Associates, are nonlawyers (and thus not eligible for membership in the Association) who have an interest in the work of the Association.

### Privileges of Associates

- Attend meetings of the Association, including sessions of the House of Delegates and the Assembly, and enjoy any floor privileges extended to Associates.
- Receive Association publications that are regularly provided to all members of the Association.
- Be appointed to any Committee or Commission of the Association for which Associates are eligible for appointment.
- Receive benefits available to ABA Members, with the exception of the insurance programs provided through the American Bar Endowment and the American Bar Insurance.
- Affiliate with one or more of the Sections, Divisions, and Forums of their choice, upon application and payment of the annual Section, Division, and Forum rates then in effect. All Associates under the age of 36 shall automatically become Associates of the Young Lawyers Division.

Submission of this application constitutes agreement to abide by the Association's Constitution and Bylaws. These can be found on the ABA website at [www.abanet.org](http://www.abanet.org). The ABA fiscal year runs from September 1 through August 31. Associates joining after October 1 receive a prorated credit towards next year's dues. Section, Division, and Forum dues are not prorated. Associate dues are not deductible as a charitable contribution for income tax purposes but may be deductible in part as a business expense. The ABA estimates that 2% of your Associate dues are allocable to lobbying activities of the Association, and therefore are not deductible for income tax purposes as ordinary and necessary business expenses.

\*\*The ABA Fund for Justice and Education (FJE) is a 501(c)(3) charitable fund that supports law-related public service and educational programs. Each year, the FJE supports nearly 200 public service programs conducted by the ABA. Your voluntary contribution to the FJE is tax deductible to the full extent allowed by the law.
