1. 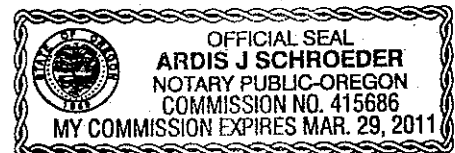

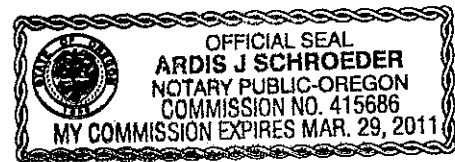
